I am a resident of Petaluma ([REDACTED]). I am also a member of Petaluma's B'nai Israel Jewish Center.

I understand that there are activists that are requesting the city council weigh in on the war between Israel and Hamas.

I am opposed to the city council weighing in on this matter.

A preliminary question is whether the council's role and responsibilities include weighing in on international affairs. Has it done so in the past, will it do so in the future and, if it is so inclined, what will be the objective and subjective criteria that the council will develop to determine whether it should weigh in on an international matter? Weighing in on this international matter would set a precedent. My opinion doesn't really matter on this issue, but I believe it is important for the council to develop objective and subjective criteria, if it is amenable to considering a ceasefire resolution, so that supporters and opponents can provide applicable input to the council.

A secondary question, if the council determines that a ceasefire resolution should be considered is whether it should adopt such a resolution. I fear that a ceasefire resolution, no matter how benign, will stoke antisemitism within our community and will attract greater pro-Hamas activism in our city. The community, at large, will not read the resolution, it will simply absorb the headline that "Petaluma calls for ceasefire". While a ceasefire sounds benign, it is not. It paints Israel as the aggressor and Hamas as freedom fighters. As we have all seen across the United States in communities and on school campuses, calls for "ceasefire" have been linked arm-in-arm with antisemitism. The implicit message of a ceasefire resolution is one of hatred towards Jews. It leaves the Jews within that community feeling unsafe and unwelcome. I have never felt unsafe or unwelcome in Petaluma. In fact, since the Hamas massacre on October 7, I have felt embraced and supported by my Petaluma community - liberals and conservatives alike.

Before she passed away, my mother was a longtime resident of Cotati and owned a business on Main Street in Penn Grove. Many years ago, she told me proudly of the Jewish Chicken Farmers of Petaluma. I moved here, in large part, because of that rich history. I now live next door to Joe and Fran Piotrkowski, who have lived on that land for over 70 years and are part of that proud Petaluma Jewish Chicken Farmer legacy. Please support our place in the Petaluma community at this very critical time.

I ask the council to reject calls for a ceasefire resolution.

Dear Petaluma City Clerk,

I would like to enter into public comment by way of information for the City Council meeting on 1/8/23 South Africa's brief to the International Court of Justice (attached) requesting an investigation of possible genocide in Gaza by the state of Israel.

I submit that it is appropriate for the City Council to go on the record as supporting a Ceasefire in Gaza as the possibility of extended war, including the possible use of nuclear weapons, is spreading throughout the Middle East. The deleterious financial, political, and moral impacts already blowing back upon our Homeland for subsidizing and encouraging the continuous assault on Gaza, are increasing daily due to rising threats to international security rooted in the invasion of Gaza, and the correlated increase in attacks by Hizbollah and Israel on the border with Lebanon, and the strong possibility of a war between Iran and Israel, which would be a global catastrophe of unimaginable magnitude.

The suffering endured by the civilian population of Gaza is extensively documented by the ICC brief, and that suffering is not justified by any human rights metric or international law, despite the attacks on civilians by Hamas. It is well known that, historically, the federal government listens when state and local governmental jurisdictions raise their voice to weigh in on matters of tremendous importance to national security and the well being of all. While not all of the members of this Council may agree that the matter of calling for a Ceasefire is weighty and deserving of public attention, it is clear that substantial numbers of Petalumans are deeply concerned about the harm's caused to humanity and to our society by the ongoing war against Gaza. Calling for a ceasefire should not be controversial, it is simply an act of basic decency, and such a measure can contribute to the saving of thousands of lives, as many other Bay Area governmental jurisdictions are recognizing. Failing to act, is itself a statement of position. As a journalist covering Council meetings, I do not normally participate in comment and petitioning, but the issue of calling for a Ceasefire is of such historical weight and importance, that I cannot be silent.

Reasons for the Letter:

First, I contend that the argument that the City Council should only be involved in local matters is contradicted by the fact that the City Council has been and continues to be involved (and rightly so) in matters of importance, nationally. Second, in the next part of this email I make a case for a ceasefire resolution. Thank you for considering my views.

City Council is involved in National Matters, now:

There is no question that the City Council is directly involved in matters of importance to the nation as a whole. What else do programs like Cool Cities, like the Climate Action Committee, like the effort to ban new construction of gas stations in the city, and like Blue Zones represent? Each is designed to make our city an integral part of a much larger national space that enables all participants in it to have good quality, meaningful lives.

By taking part in these programs, we demonstrate our commitment to participate in the affairs of the nation as a whole, and not just constrain our sphere of activity to that of a small city in California. This reflects the fact that we are a progressive city, dedicated to doing our part in eradicating many of the things that threaten our well-being, both at the local and the national levels.

The Justification for the Petition for a Ceasefire:

What is the rationale for the ceasefire petition we would like to put before Council? There are several reasons, and I shall list them.

First, there is no justification to respond to an act of injustice with another injustice, when those most likely to be affected are innocent civilians. Hamas did a horrific thing: killing over 1200 Israelis and taking 240 hostages. But it is also terrible to retaliate in ways that cause the deaths of 22,000 people, seventy percent of whom are women and children.

It needs to be pointed out, as well, that responding to Hamas' brutality with Israeli brutality will always be counterproductive. In fact, taking this course will only create a huge supply of recruits to Hamas, leading to a situation in which even if Israel defeats Hamas, another version of this organization will certainly reappear, and it may be worse than the present one.

Second, listening to the Israeli government discuss its approach to the war clearly suggests that it is not on the same page with President Biden. The latter wants to have a two-state solution, one state for Palestinians and another for Israel, living next to each other in peace and

justice. But this situation is unlikely, given the annexation mentality of the current government. It seeks to annex as much Palestinian land as it can in the occupied areas of the West Bank and transfer it to Israeli control. On the vacated land the government of Israel would build new settlements that can only be occupied by Jewish Israelis. Not only does this approach violate U.S. law, since it supports exclusion from housing opportunities by ethnicity, but it violates the prospect of a Palestinian State with equal rights under law for each Jewish and Palestinian citizen.

Third, the war could expand beyond the current boundaries to include Iran and Lebanon, if not eventually Syria and Iraq. We must prevent the expansion of the war, and the best way to do this is with a ceasefire. If we fail, there could be American soldiers placed into harm's way, perhaps even losing their lives. It is a long known fact that often nations back their way into wars they would initially have preferred to stay out of. We are on the precipice of doing precisely that. A ceasefire resolution tells all parties to the conflict to stop now, before the war spirals out of control. It is only with a ceasefire that we can create a space for reasonable people to enter the picture and search for a just resolution.

Fourth, the war is in large part being funded with U.S. tax dollars, dollars which we give outright to Israel. But dollars provided exclusively to one cause may not allow dollars to go to other causes. It seems to me that Congress should at least discuss the expenditures we are providing Israel to support the war, as part of a broader discussion of how our American cities would like to see the money used. And this issue, in and of itself, makes it absolutely mandatory that cities must have a voice in the matter. A ceasefire resolution would communicate this message loudly and clearly to our leaders at the national levels. Thus, whether we like it or not, we are enmeshed (or at least should be) in policy planning that requires our city's immediate and direct involvement in national politics.

Fifth, Israel, as I said earlier, is killing predominately children and women, not only with 2000 pound bombs but with massive, all pervasive hunger and the ever more widening path of deadly diseases. As such, it is involved in an effort to prevent the Palestinians as a people from having a future. That crime against an ethnic group is, to use Raphael Lemkin's term, nothing short of genocide. I do not see how in the face of this situation that any of us can do anything but demand a ceasefire now.

In my view, this is not just a political question but a moral question of great significance. Having a discussion on a ceasefire is the least we can do to ensure that we have carefully weighed all the issues involved. People of conscience may disagree on the outcome, but given the gravity of this situation, how can anyone say it is in our city's best interest to avoid the issue?



By definition, downtowns are the best place for density. It is possible to respect the amazing historic character of our downtown while still allowing the town to grow, ameliorating the housing supply crunch that is currently pricing-out average citizens.

What City Observatory did this week

[A \\$9 billion Interstate Bridge Replacement Project?](#) Just 13 months after raising the price of the Interstate Bridge Replacement (IBR) project by more than 50 percent, the Oregon and Washington DOTs say it will cost even more. We estimate project costs are likely to increase 20 percent or more, which would drive the price tag to as much as \$9 billion, almost double the 2020 estimate..



While the DOTs blame “inflation” their own estimates show construction cost disinflation, with expected increases of no more than 3.5 percent per year for the rest of the decade. The likely increase in costs will more than wipe out the \$600 million in federal funds awarded to the project in December. The cost of the IBR is increasing faster than the DOTs can find money to pay for it.

The “Cost Estimate Validation Process” (CEVP) that state DOTs implied would remedy future cost increases utterly failed. The use of lowballed construction cost estimates to sell highway megaprojects is part of a consistent pattern of “strategic misrepresentation.” It’s the old bait-and-switch: get the customer to commit to buying something with a falsely low price, and then raise the price later, when its too late to do anything about it.

ODOT has a consistent track record of lowballing pre-construction cost estimates, and recording huge cost overruns, with the average price of a major project doubling between pre-construction estimates and final costs.

Must Read

Housing is up, rents are down. Jay Parsons of [Realpage](#) reported that 2023 was a banner year for apartment completions. In 2023, the US completed nearly 440,000 new apartments, the highest number in about 35 years.



The surge in apartment construction has been a key factor in bringing down rental price inflation--something that will increasingly show up in the national inflation numbers in the coming year. But real estate markets are local, and the big improvements in supply are producing the greatest rent relief in those markets that are building the most. As Parsons writes,

. . . there remains a clear link between supply and rent change by market. Rents fell in 2023 across 40% of U.S. metro areas – and nearly all of those saw significant new supply entering the market. By comparison, nearly one-third of U.S. metro areas produced rent growth of 3% or more in 2023, and nearly all of them had little supply to work through.

The good news is that the surge in apartment completions is likely to continue through 2024, with more than 650,000 new apartments expected to be finished. There's clear evidence that expanding supply helps making housing more affordable.

Upzoning increases supply and lowers rents. The principal policy tool that local governments wield to regulate housing supply—zoning—turns out to be a critical way to improve housing affordability. Todd Litman summarizes the growing global literature showing how upzoning leads to more housing construction, and in turn, improves housing affordability. Writing at Planetizen, Litman surveys a series of careful academic studies documenting the positive effects of upzoning. One of the most striking examples comes from Auckland, New Zealand, which saw big increases in housing following its upzoning in 2016:



Whether the present surge in apartment construction continues, and whether it reaches the markets that need additional supply the most, will hinge in important ways, on whether local governments upzone for more supply.

Some state DOTs are climate deniers. More than 20 states are suing the US Department of Transportation over regulations that would require state Departments

of Transportation—which receive billions of dollars of federal funds—to measure and report the greenhouse gas emissions associated with their transportation systems. Streetsblog reports that this dirty dozen and a half don't want to have to even discuss the fact that the systems that they run are now the single largest source of greenhouse gas emissions in the US. As Transportation for America's Beth Osborne says, the state DOTs are either dishonest or climate deniers (or both):

"They're saying they don't have the capacity to measure greenhouse gas emissions, and in the same [document], they're saying they do; I'd like to know which it is," Osborne said. "Do they have the information, and they *could* share it, but they just don't want to? Or are they unable to determine the carbon impacts of their investments? ... Because if they can't, maybe we shouldn't entrust them with this money in the first place — and give the money to the cities, which could."

This lawsuit is just part of a pattern and practice in the transportation engineering industry to deny climate change: As we've pointed out, they're content to build us a [highway to hell](#).
