Dear Councilmembers -

First, thank you for your service to our city. Local civil service is vital to our daily quality of life: you are appreciated.

Ten years ago, when my husband and I were moving to California - returning home to the Bay Area for him and relocating for myself - we looked extensively around the North Bay to decide where we wanted to raise our own family and put down roots. Petaluma quickly became our obvious first choice. The community we have here is priceless.

The heart of that community, and a key selling point for us in buying a home here, is our downtown, with its small town feel, historic architecture, and manageable crowds and parking. The local businesses in our downtown support our kids' schools and provide local options for shopping and eating out that bolster our neighbors' bottom line rather than big name corporations or developers. Petaluma has even recently (rightfully) made the news for its historic charm. We love it here and are continuing to invest in our community by giving our time and resources to our kids' school, Scouts, youth sports, building our own business here, and so much more.

The impact of the proposed Overlay and hotel is more than just "environmental" or "economic": It will impact how our town *feels*. Is it welcoming? Do you get that homey historic vibe? Or do you get the sense that the town's just sold its soul for an increase in occupancy tax revenue? I feel strongly that it will be the latter.

And we don't even need it.

The data that I have been able to find on occupancy rates (including the most recent Sonoma County Annual Tourism [Report](#)) and the Research and Insights: Tourism in Sonoma County [website](#), occupancy percentage rates maxed out in the low 70s both of the last two years. This does not provide a strong enough demand signal to make it worth the damage that this project stands to do to the heart of the community I have grown to love. The potential transient occupancy tax from the development doesn't provide enough monetary gain for the city to be a compelling reason to move forward.

We are often infatuated with the idea of progress, with the idea that we must be always changing things, but ultimately, preservation - of the environment, of our community, and of how a place can make us *feel* - is equally if not more important. This is the type of damage that cannot be undone. I strongly urge you to protect the Petaluma we all love so dearly and reject both this overlay and the hotel project it would enable.

Subject: EKN Appellation Hotel and Zoning Overlay

We were told that after the 1906 earthquake, out-of-towners flocked to our grandparents' Swiss American Restaurant on Main Street and dined on cracked plates.

Remarkably, the earthquake left our Petaluma downtown buildings largely undisturbed. Now, 119 years later, the City Council is prepared to take actions that could irreversibly harm our City and historic district.

As third generation Petalumens, we strongly oppose the proposed "economic opportunity" zoning overlay and the EKN Appellation Hotel. Fundamentally, the hotel is oversized. Furthermore, the design doesn't enhance the historic district, significant parking and traffic issues would result, and economic claims are dubious. These further issues were not addressed (not "required" to be addressed) by the EIR. The classification of historic downtown structures was incomplete and contained errors. No alternative hotel locations were considered.

Other than to provide for the hotel proposal, the benefit of a zoning overlay is unclear. Calling it an economic opportunity zone does not make it one. The potential impacts of the overlay, beyond the specific hotel proposal, have not been addressed. The consequences of potential height and density overrides under state laws have not been clearly outlined.

It appears the City Council reacted to the potential tax revenues from the hotel without real data about downtown properties. Why hasn't there been a thorough review of the vacant properties and storefronts in the downtown historic district to understand why they remain vacant or undeveloped? This seems like fundamental analysis before designing an economic overlay. Facts, not just anecdotes, are required.

As a community, let's identify measures to preserve and improve our treasured historic downtown. And yes, let's encourage development that compliments and enhances Petaluma, and does not contribute parking and traffic concerns.

I once again write to share my deep concerns and negative vote for the overlay & hotel in the Historic District of downtown Petaluma.

Besides it being totally out of character for the town, it breaks the height limit for buildings in the Historic District and uses 100% of the lot giving no space for walkers, trees or vegetation.
