I am writing to you to see if we can align our values with our climate goals.

I'd like to highlight and discuss the discrepancy between why Petaluma is willing to continue using Artificial turf even though they have clearly defined climate action goals that are aligned with banning it. In this document written by Deb Fox, it states, Petaluma will continue to keep and install Artificial Turf even though later in the document it states natural grass is a great option to sequester carbon.

My question is, given the high cost of installing a Artificial turf field like the quote for Lucchesi (\$2.5 million) vs. Installing a native natural grass field like the one at Riegel Ranch costs, \$250,000, a fraction of the cost to install and maintain.

Is there anything you can do to encourage the city to make better choices? Upfront costs are less to install a natural grass field, long term costs of maintenance is less, and the whole field won't have to be removed in 7-10 years.

Plastic Grass fields with crumb rubber infill is toxic to make, is made from materials that are too toxic for our landfills and is being used for children and community athletes to play on. The Artificial turf pollutes when fabricated, installed, and constantly off gasses and sheds toxins into the environment while it sits in our town for 7-10 years. Then it costs \$40,000 to remove and haul off to be incinerated which leads to further pollution.

There is a natural native grass new gopher eliminating technology that has been implemented at Ragel Ranch in Sebastopol. I hope that we can learn from their success and get safe plying fields for our town too.

Counties and states recognize the PFAS found in Plastic Grass are contributing to cancer and other environmental issues. I think it's time Petaluma take the lead in placing a moratorium on Plastic Grass installs effective immediately. Then banning Artificial landscaping.
