To the City of Petaluma staff and the city attorneys of Petaluma,

We as Youngstown residents are providing to you our petition of Youngstown residents with demands for the park owners of Youngstown, Three Pillars, and Daniel Weisfield and WGP management of the following:

The original 55-year-old senior parks signs that have always been in place but were removed by management 2 weeks ago be put back up immediately at the front of Youngstown Park as well as throughout the community.

Immediately remove the new signs, brochures, and the advertising on the web on the park owned new mobile homes up for sale that state all age park.

We were not an all-age park in the past, new status change to park can not go forward Feb 1st as they noticed us with rules and regulations and the senior park overlay is law now.

(7 Belle was sold last week as an all-age park unit)

Deliver to all residents' new rules and regulations that are for seniors as notated in the senior park overlay zoning designation,

Youngstown management is attempting to use all age rules and regulations that cannot go into effect on Feb 1st.

Void the 6 month noticed rules and regulations that Youngstown Park owners wanted to take effect Feb 1st that would not follow the senior park overlay zoning designation.

Clarify that leases and purchase paperwork state senior park and not all age.

We further demand that management stop telling other Petaluma Mobile Park managers that we are an all-age park and cease and desist telling real estates agents showing properties in Youngstown or representing clients that this is an all-age park.

Youngstown residents seek these remedies to be corrected as defined in the senior park overlay zoning designation and reiterated in the ordinance which became law today November 16, 2023.

We would like to be informed how the city of Petaluma will help police the very revisions and zoning designation made law as management and park owners have circumvented our efforts to seek these remedies ourselves.

We thank you in advance for your diligence in making our community of Youngstown residents protected by the very ordinances of our city,

We will give management and park owners till Nov 16th to remedy these violations of the ordinance.
