Hi my name is Ma'ayan, I'm an israeli-american jew, and a Petaluma community member. I call on the City Council to adopt a ceasefire resolution.

I was staying at my mom's house in Tel Aviv on October 7th, when I woke up to the sound of sirens and explosions of bombs. As the horrors of Oct 7th progressed I felt three things, sadness at the loss of Israeli life, fear for Gazans in the face of an Israeli retaliation, and fear of the inevitable increase in antisemitism that would follow a genocide performed in the name of the Jewish people.

Antisemitism is real, and I fear it continuing to rise if we don't stop the genocide done in our name. I do not fear an increase in anti-jewish hate after adopting a ceasefire resolution. Instead, a ceasefire resolution shows a commitment to all human life. A commitment to the return of Israeli and Palestinian hostages, a commitment to the end of the ongoing horrors CURRENTLY being levied against Palestinians, and an acknowledgement of the atrocities of October 7th. A ceasefire resolution, proposed by this coalition of LOCAL jews and palestinians, allows jewish, arab, and muslim communities in Petaluma to come together in support of each other and the sanctity of life. Neither Israel nor B'nai Israel represent me and I AM MAD that the mayor gave Rabbi Shalom the power to represent ALL of Petaluma's jewish residents on the question of a ceasefire resolution.

I was raised a Zionist, taught to fear Palestinians and Arabs. Taught that my freedom is only possible at the cost of Palestinian self-determination and liberation. I mourn the innate humanity and empathy that I had to abandon as a child to understand this. But, now, I am proud that I broke through those teachings, that I listened to the lessons my Holocaust Surviving grandparents taught me. I am proud to be an Israeli Jew standing here with this community calling for a stop to the genocide. I demand the council listen to my JEWISH voice, and mitigate antisemitism by calling for a stop to the genocide that is being done in our name. Never Again & Not in our Name

Sonoma County Fire Tax Measure

SCF is initiating a "Special ½% Sales Tax" measure throughout Sonoma County on the March '24 ballot. The same initiative was attempted in 2020 but did not pass, requiring a 66 2/3% majority. Not to be deterred, the Fire Districts were able to reduce the needed majority to 50% of the vote in '24. The Fire Chief's qualified for the reduction by gathering a minimum of 19,746 valid signatures (5.8%) of qualified registered voters.

If passed, the initiative will provide all the cities and fire districts in Sonoma (volunteer or paid) \$60 million dollars in addition to their property and parcel taxes they currently receive which comes to 27% for Districts and 9% for Cities. If the Measure passes, Petaluma will receive \$4.25million (7.09%). That may sound pretty good but it will cost Petaluma \$7.882 million in sales tax and don't forget Petaluma just passed a 1 % sales tax in 2020, "Measure U" for \$15 million that includes language to "maintain and prevent cuts to firefighting equipment and to provide adequate 24-hour staffing".

The \$60 million will be allocated by the Sonoma County Fire Chiefs in percentages to each city and fire department. In addition to each City and Fire District receiving their percentage, the Fire Chiefs have also allocated 14.05% to the "Sonoma County Fire Chief's Association". This amounts to 8.5 million to do with as they see fit, not to mention annual increases as sales taxes increase each year. The Chief's state that this money will go to pay for services such as dispatch they currently receive and that they will allocate funds to improve the local dispatch center (REDCOM). What happens with 8.5 million dollars after their remodel projects are complete? Should the Fire Chief's even utilize special funds to remodel a facility owned by the County and operated by the County Sheriff's Office?

I am not surprised at the direction the Fire Chief's and the County have taken to sustain their existence. The Fire Chiefs have done a good job of consolidating departments and their troops are dedicated and professional, but the County has not been able to fund their financial needs, goals and objectives. As taxpayer in Petaluma, I don't see the connection between our sales tax money being required to support a "County Fire Tax". Petaluma, Rohnert Park and Santa Rosa are City Fire Departments and supported by their tax payers. They are not part of a Sonoma County Fire Dept. or are they going to be incorporated into a County Fire Dist.

The County assures us that the tax measure will be monitored by an oversight commission to assure the funds are being dispersed as proposed. These monitors remind me of the efficiency that we see with the Public Utility Commission and the Golden Gate Bridge Commission; they sure have represented the tax payers well.

We can get the Sonoma County Fire Departments in better shape than they are today but I think it could be done more responsibly. To sell this as an issue for Petaluma, Santa Rosa and Rohnert Park is disingenuous and appears to be a long-term money grab. A tax measure to support the Fire Districts for 3 years, until they get on their infrastructure and equipment established could have been a more constructive solution. At the end of 3 years, let their own communities support them. I am voting NO on the County Fire Tax Measure.

All Petalumans qualify for Geneva Convention rights, principles of International Law seeking to protect civilians in combat zones, established to prevent the atrocities of WWII. Petaluma includes ~~a~~ Jewish and Palestinian heritage residents. Councilman Healy, an honorable man, desiring peace in our community, voiced concern a ceasefire resolution might lead to hate crimes here.

The city of Davis ceasefire resolution yielded no such incidents according to their Police Dept which collects that data. Hopefully this can help calm ~~my~~ fears at the Synagogue in my neighborhood and the Islamic Center in my neighborhood, and among my Arab Christian neighbors, that a Peace Resolution would harm them in any way.

We who bring this resolution are Jews, Muslims, Christians. Humanists with a deep sense of urgency saying "Never Again," no more civilians killed or denied food, water, medical care, shelter. No more dead children. The Geneva Convention works only if local communities join in speaking up for human rights, against hatred and violent bigotry. Americans in the 1940's ignored evidence of the Holocaust and said, "It is not our problem." We urge you to speak up for peace now and recognize our interconnectedness, to speak up without blame or rancor, reflecting goodwill and respect to all, compassion to all.
