Mayor and City Council members,

Reaching out regarding the 5400 Redwood Hwy project that is on the agenda for potential rezoning prior to annexation proceedings. This project puts our "Zero Net Fill" policy to the test.

Of course flooding was a concern going into the PC meeting where we reviewed this item, but when we arrived at the meeting we received a copy of the 2015 memo signed by council-member Healy rejecting annexation overtures made at that time. This memo became a center of PC discussion. We were guided by staff that the current 2024 application for annexation differed in character to the 2015 attempt, and therefore we did not necessarily have to remain consistent with the determination from 2015, which was to reject annexation due to the 11,400 yards of fill.

PC asked in our approval vote that it be passed on to council to determine whether or not this new zoning and eventual annexation attempt differs appreciably compared to the 2015 effort that was rejected. As additional context, you all know that we are preparing to expand our "Zero Net Fill" policy in the GP 2045 frameworks from only parcels North of the weir to many more parcels within the floodplain. We have to take care to enforce existing and future "Zero Net Fill" regulations consistently. As I reread the 2015 council memo, it's hard to see how one can deviate from the seemingly consistent determination council has repeated since 2002 that the fill must be removed "before annexation or the provision of water or sewer service" for this parcel.

I have not fully reviewed the 5/29/24 report, but I did read it's conclusion. It will be interesting to see where this lands and I look forward to the discussion.
