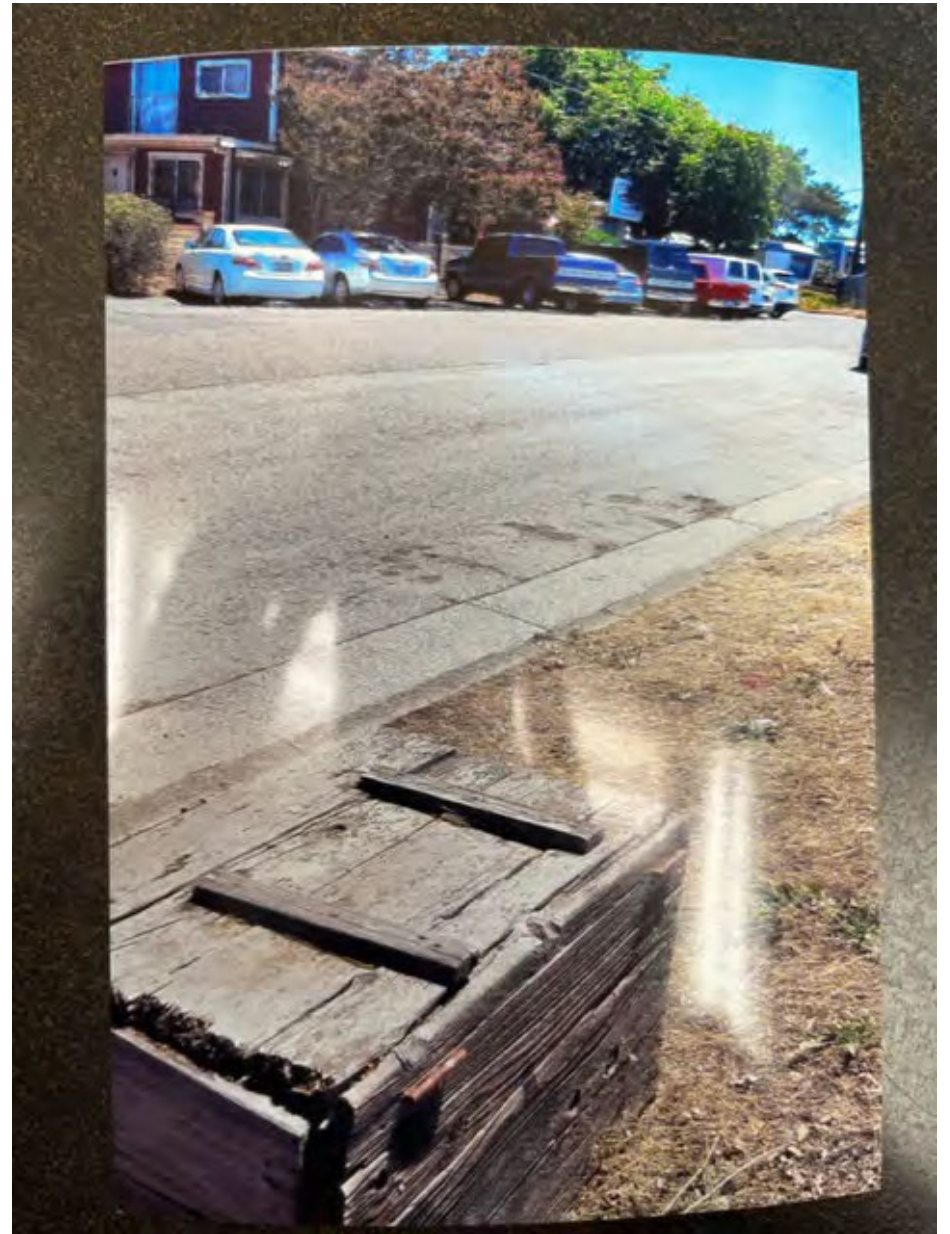

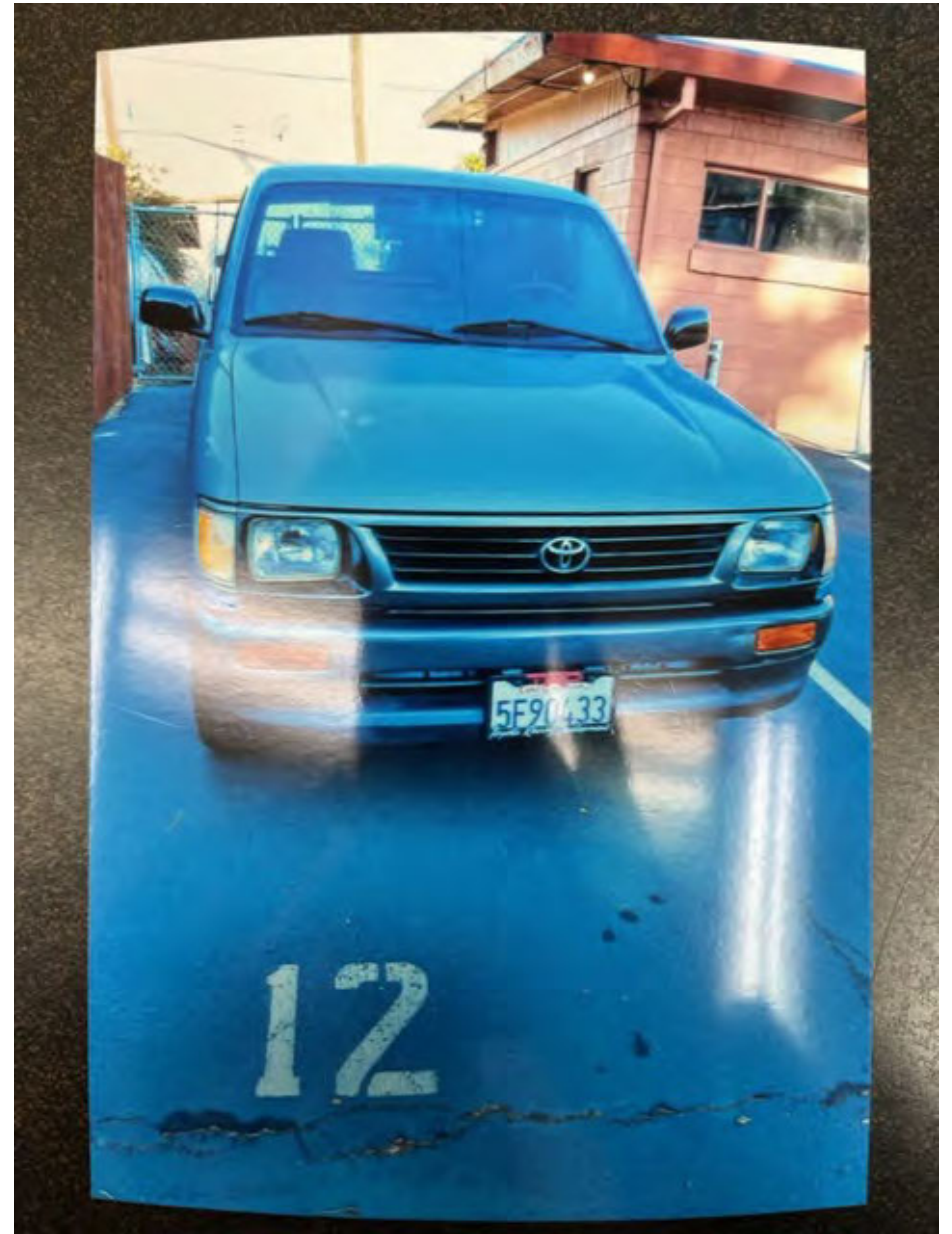
Dear Council Members

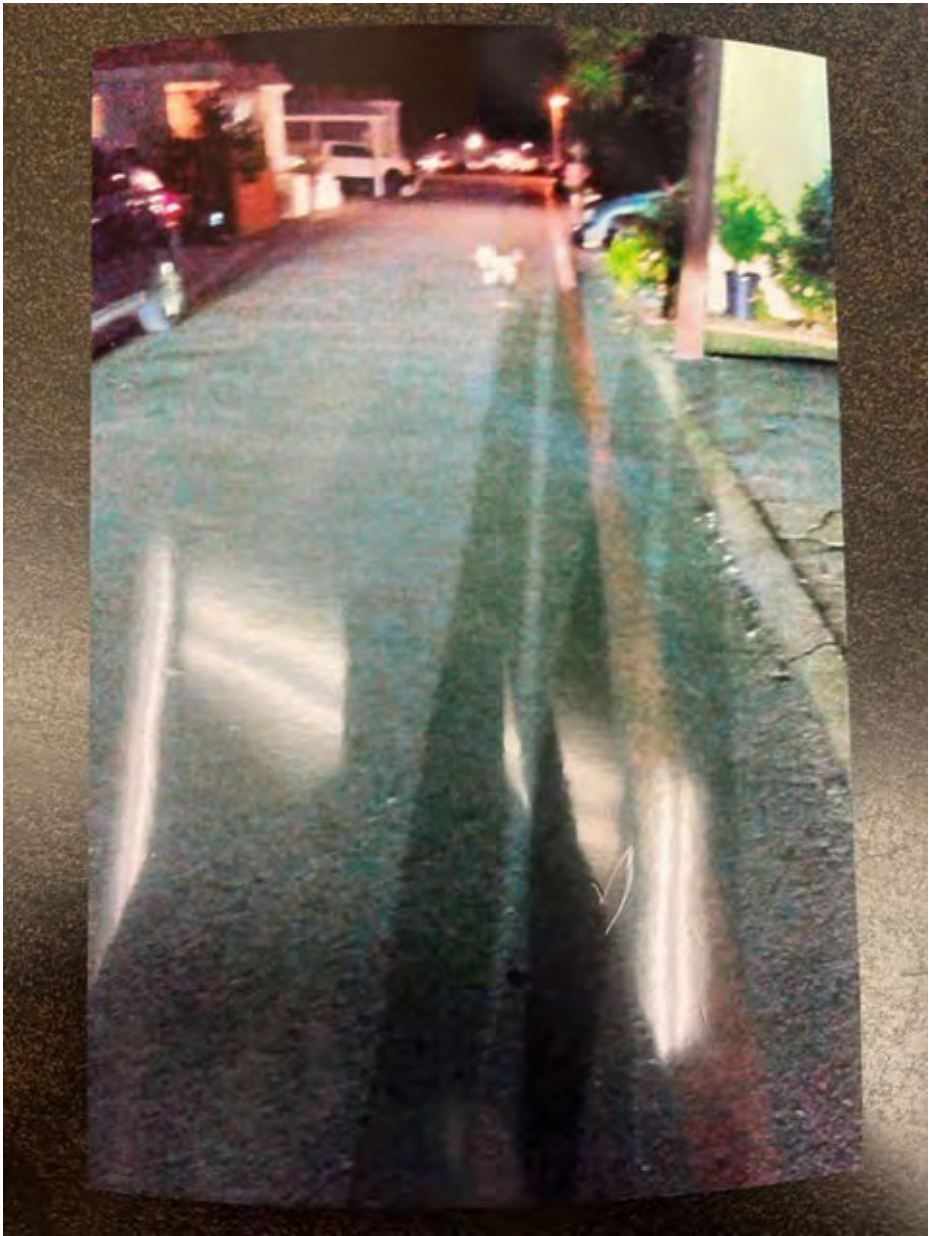
Hi, my name is Laurie Schroeder. I have Autism, my friend Katherine Bobrowski lives at 1821 Lakeville Highway Space 31 Petaluma, CA 94954. Little Woods Mobile Villa Mobile Home Park. I am a witness to what is going on here. I have pictures and so does her attorney Evan Livingston also has pictures also. Her manager Dlocela Cruz, her family and her friends are breaking all the laws in the mobile home park like not parking in the driveway. They are parking their cars next to her mobile home at Space 31. There is Illegal Invented 12 on the ground right at the propane tank there. That is not a Illegal parking area at all. Danny Cannon and his friends Invented 12 Illegally. Every car parked at her mobile home did a lot of damage to it. They have parking spaces in back of the park. Illegal parking spaces two 5, two 7 and so on. They are not 1, 2, 3, 4, 5 and so on. Dlocela Cruz her lover Robert Cook from Stonegate Mobile Home Park in Santa Rosa Invented illegally space numbers in the back parking lot and Perry Lane and she parks in No Parking and her brother also and Illegally doing drugs. The street lights not fixed too dark at night. Swimming pool is a health hazard, no sign posted. Illegal water pipes are full of cement and dirt not metal plates across it. There are over 50 people living in each mobile home alone. All related to Dlocela Cruz. Dogs are not on a leash at all. Illegally against the law. They blast their music full blast at night also. The slides are not fixed they are full of cracks on both sides of the park and

They are uneven, holes in the street also, the pictures that Rafter he
 her attorney Evan D. Whigton and myself as a witness have seen
 everything that the on site manager Dixela Cruz, her family
 and her friends has done to the mobile home park. We are asking
 all of you to get these people out of the park as soon as possible
 and to get a new manager in that can fix everything. Also
 these people keep banging on Katie's door for no reason at
 all. So if I tried to stay there overnight for 2 or 3 nights and have
 a nice dinner there Dixela Cruz, her family and friends would
 bang on her door. Her pastor from her church can't drop something
 off to her not even 1 minute either. They also steal her mail
 and cancer medical supplies. The police said her family and
 friends can break the law. The police and the fire marshall can't
 get those cars towed away off the fire lanes because they are
 friends to on site manager Dixela Cruz, family and friends. They
 have drug friends also so all of them are doing drugs, smoking
 and drinking alcohol a lot. Katherine is being harassed, yelled
 at and being wrecked by all of them that is why they call it a cage
 her mobile home. Other from that the side walks in this town
 are not fixed on Petaluma Blvd. N/S and by Post office. The boards
 at the waterfront are coming up need to be hammered down. The river
 is dirty, the police are harassing the homeless and are not breaking
 the law. They need empty buildings. There is no security cameras in the
 mobile home park because on site manager Dixela Cruz, her family
 and her friends are doing illegal things here. That also goes for shopping
 centers, businesses everywhere else. If you have any answers for all of

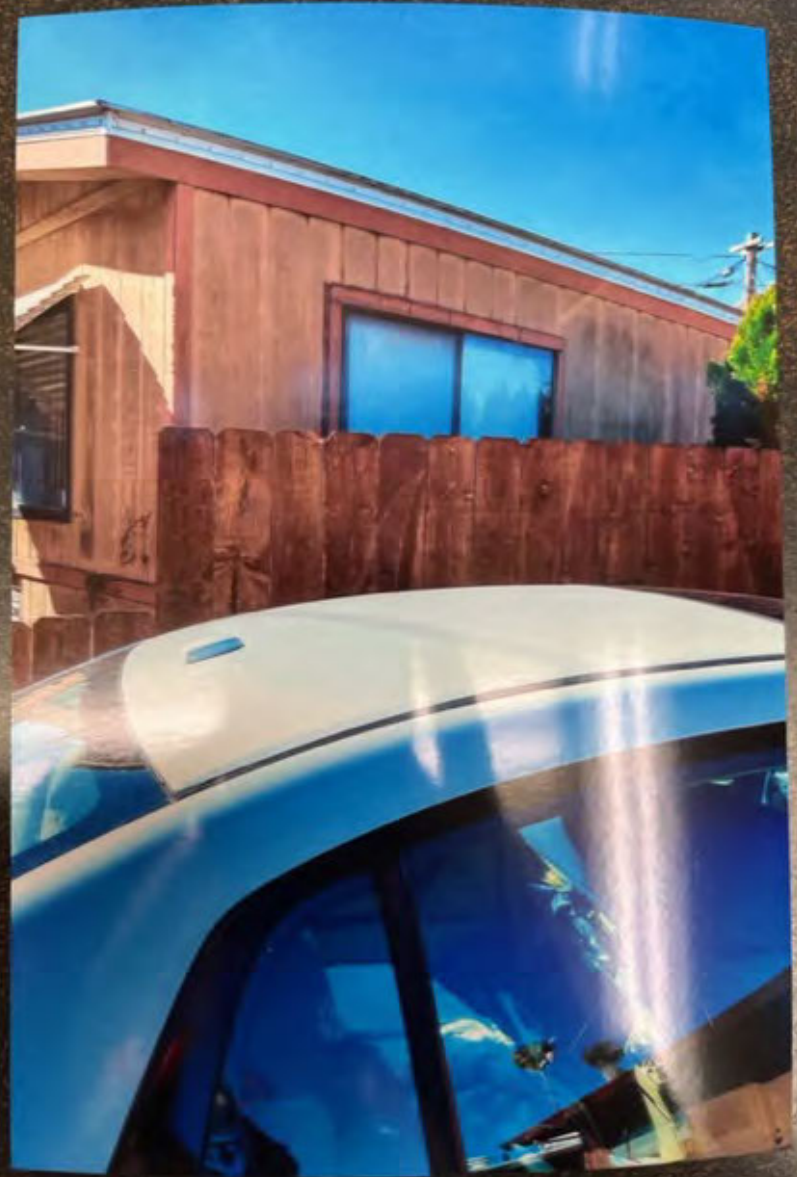


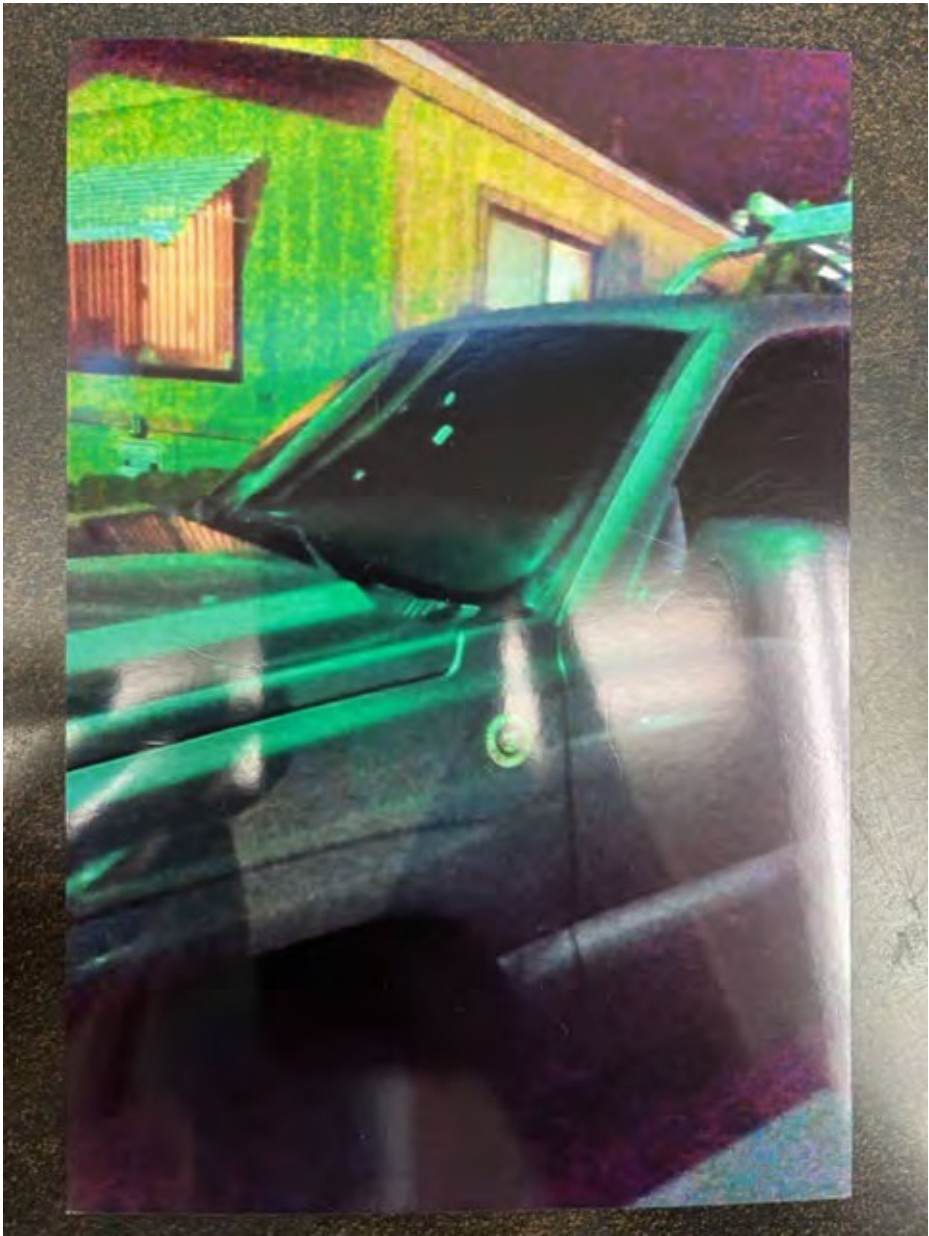






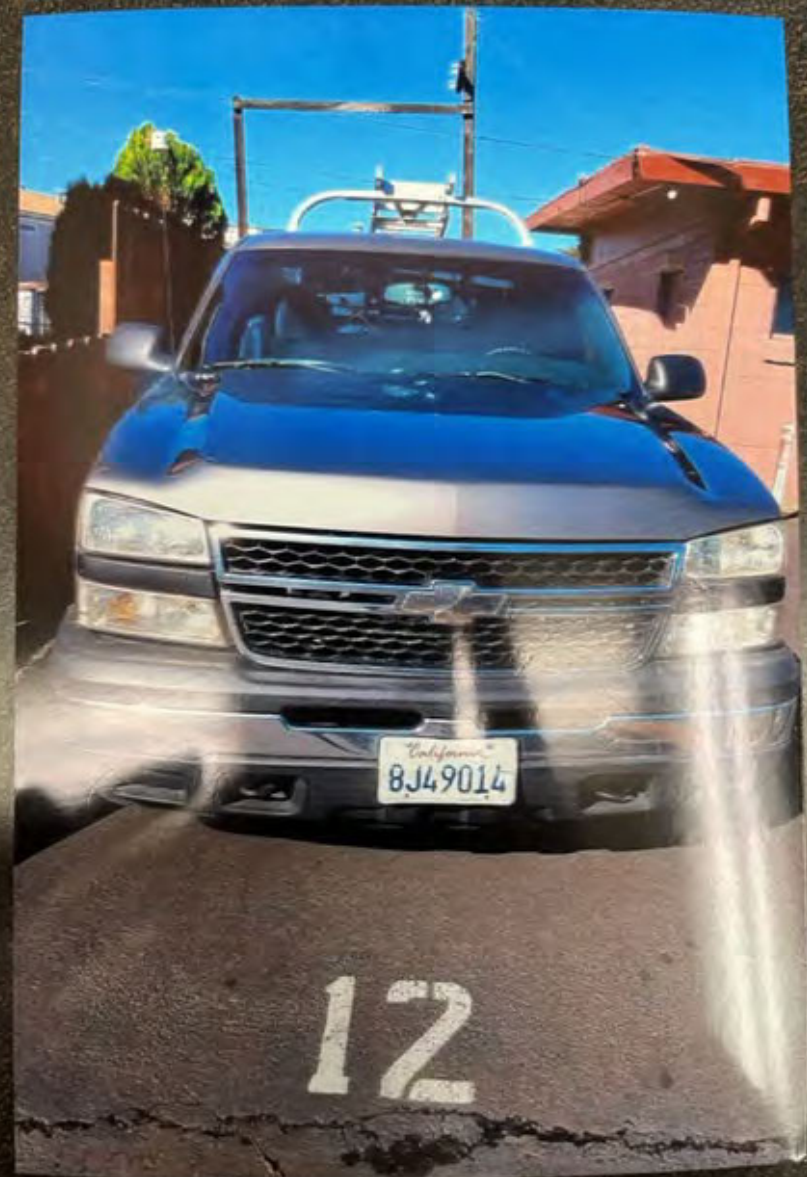
