She has her family and friends park their cars any place they want to and not in their drive ways. The swimming pool is dirty. The dogs are not on leashes at all. The sidewalk is uneven. The street has cracks in it. The water line has dirt-concrete not a metal plate to it. The street lights are out. There are inverted lines that she did with her lover Robert Cook from Stonegate Mobile Home Park in Santa Rosa.
