### **CONSENT CALENDAR**

Mayor Barrett invited Assistant City Manager, Brian Cochran, to provide an oral report of the salary and benefits included in the employment agreement for Item 5 on the Consent Calendar, as required by the Brown Act and note a revision to Page 3 of the BID item (Item 6).

Assistant City Manager, Brian Cochran, announced, Government Code Section 54953(c)(3), part of the Brown Act, provides that prior to taking final action on an employment agreement, the legislative body shall orally report a summary of the salary, salary schedules, or compensation paid in the form of fringe benefits of a local agency executive during the open meeting in which the final action is to be taken. Accordingly, key changes contained in the amended agreement are as follows: Salary: The annual salary is \$164,883; Administrative Leave: An increase to Ms. Sawyer's administrative leave allowance from 80 hours per fiscal year to 96 hours; Miscellaneous Benefit Language Clean-Up: The amended agreement trues up various portions of the benefits document with current City policy and practice, such as modifications to the holiday schedule, updating the City's health insurance contribution, etc. He further announced that a typo was found on Page 3 of the staff report for Item 6. The hearing date should read December 19, 2022, as noted elsewhere throughout the report and associated resolution, and that the revision was posted online with the agenda report.

Councilmember King and Councilmember Healy announced their recusals from Item 6 due to conflicts of interest.

Councilmember Healy asked for Item 5 to be pulled from the Consent Calendar.
