REPORT OUT OF CLOSED SESSION

Assistant City Attorney Jordan Green reported out the following from Closed Session:

The Council unanimously approved a settlement agreement in Charles S. Syres versus City of Petaluma et al, Sonoma County Superior Court case, Number Scv. 271500, which will be on file and available for public review in the City Clerk's Office once fully executed. Ms. Green provided a short summary of the agreement, noting: the parties agreed to pay their own attorney's fees, there was no agreement to an exchange of money, and Syers agreed to dismiss the lawsuit once the settlement agreement is fully executed. The City also acknowledged that under the current provisions of the City's municipal code and zoning ordinance, that Syres may make certain modifications to existing buildings and storefronts, without being subject to the Site, Plan, and Architectural Review Process, or other Discretionary Review, but only under certain circumstances. There is no intent to impose any limitation on the City's review and permitting authority. This agreement declares existing law under the City's Zoning Code and Municipal Ordinance.
