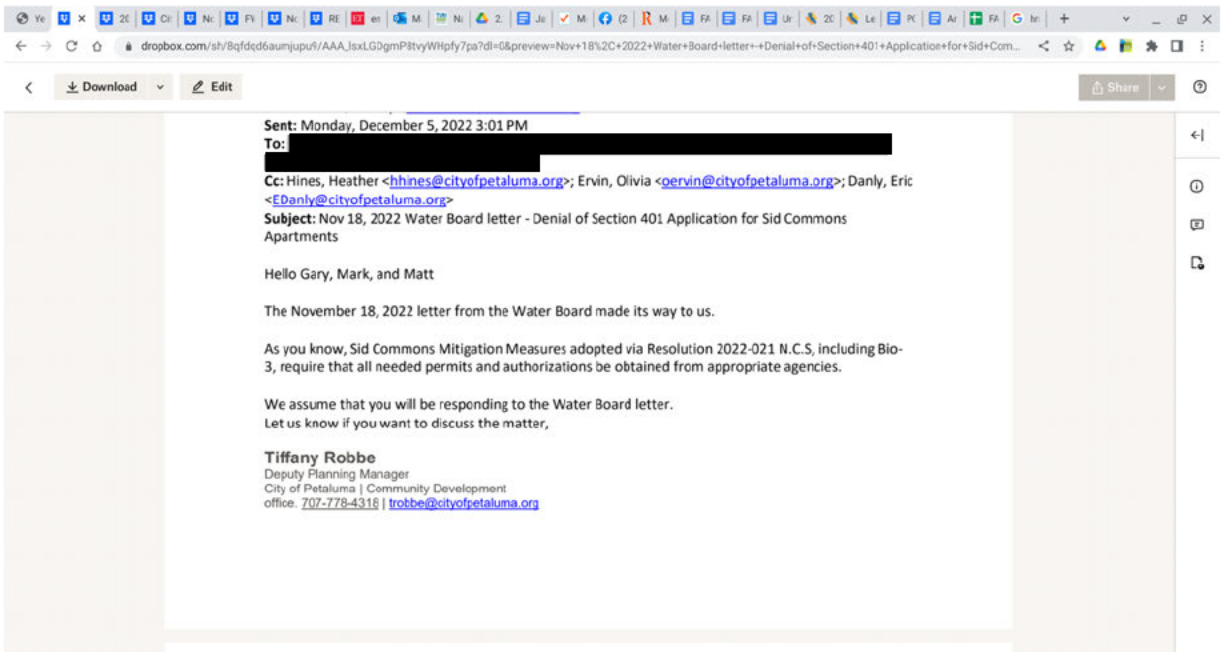
Hi Kami,

In the PRA results DropBox you provided, I see that last year on Nov. 18 2022, the City received a letter from **the water quality district that, it appears, denied the Sid Commons project to be built.**

Although the DropBox folder does not include this water quality district letter, the correspondence between the Johnson's (the developer) and Eric Danly/M Group reveals that Sid Commons was denied. This is the letter I am requesting please!
