AUTHORIZING THE AWARD OF CONTRACT FOR THE PAVEMENT RESTORATION 22/23 C16102248 TO GHILOTTI BROS., INC. AND FINDING THIS ACTION IS NOT A "PROJECT" PURSUANT TO CEQA GUIDELINES SECTION 15301

WHEREAS, in accordance with the City of Petaluma Charter and Municipal Code, California Public Contract Code Section 20162, and other applicable laws, City staff prepared construction bid documents and solicited bids for the Pavement Restoration 22/23 Garfield Dr (Project); and

WHEREAS, the project was bid on January 20, 2023, and five (5) bids were received and opened on February 27, 2020, in accordance with applicable law; and

WHEREAS, the lowest responsible bid for the project was submitted by Ghilotti Bros., Inc. from San Rafael CA, for \$2,936,976; and

WHEREAS, Ghilotti Bros., Inc., satisfies the bidding requirements for the project; and

WHEREAS, Ghilotti Bros., Inc., possesses a valid California Contractor's License, Class A #138128, that covers the work; and

WHEREAS, there were no bid protests and the time to protest has lapsed; and

WHEREAS, the Pavement Restoration 22/23 project is categorically exempt pursuant to California Environmental Quality Act ("CEQA") and Title 14, the California Code of Regulations ("CEQA Guidelines"), Section 15301 because the project consists of repair and maintenance to an existing public street.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Petaluma hereby:

- 1. Declares that the above recitals are true and accurate and are incorporated herein as findings of this Resolution.
- 2. Finds that the Pavement Restoration 22/23 project is categorically exempt pursuant to California Environmental Quality Act ("CEQA") and Title 14, the California Code of Regulations ("CEQA Guidelines"), Section 15301 because the project consists of repair and maintenance to an existing public street.
- 3. Approves the revised project budget for the Pavement Restoration 22/23 Garfield Dr. Project No C16102248.
- 4. Awards the contract for the Pavement Restoration 22/23 Garfield Dr, Project No C16102248 to Ghilotti Bros., Inc., in the amount of \$2,936,976, the amount of the lowest responsive bid, conditioned on Ghilotti Bros., Inc., timely executing the project contract, and submitting all required documents, including but not limited to, executed bonds, certificates of insurance, and endorsements, in accordance with the project bid documents.
- 5. Directs staff to issue a notice of award to Ghilotti Bros., Inc.
- 6. Authorizes and directs the City Manager to execute the project contract on behalf of the City of Petaluma upon timely submission by Ghilotti Bros., Inc., of the signed project contract and all other required documents,

including but not limited to, executed bonds, certificates of insurance, and endorsements, in accordance with the project bid documents.

- 7. Approves a construction contract contingency of \$440,000 for Pavement Restoration 22/23 Garfield Dr. Project No C16102248.
- 8. Authorizes staff to prepare a year-end budget adjustment for the CIP project as outlined in the Financial Impact Section.
