Ann Baker made a motion to recommend to Council that they adopt a resolution to discontinue new installations of artificial turf for the following reasons: microplastic pollution, extreme heat effects, it is non-recyclable, it doesn't meet our waste goals, player injury and carbon accounting.

Panama Bartholomy seconded the motion.

Ann Edminster appended the motion to request the Council adopt a policy of conversion of non-active turf areas and replace them with a nature-based solution including no-mow and alternative plantings with a preference for native vegetation.

Ann Baker spoke about a policy of replacing non-active turf areas with non-turf ground covers and over time converting existing astroturf fields with natural grass.
