Capital Project Updates

- **D Street Traffic Calming & Active Transportation Quick-Build:** Project update sent June 28 and posted to webpage at cityofpetaluma.org/DStreetTrafficCalming; planning to go to bid this summer and install Phase I improvements in fall
- **5th Street Neighborhood Greenway:** To be bid and installed with D Street Traffic Calming Phase I (see above)
- **N. McDowell Complete Streets:** Paving underway; presenting update and seeking Council feedback July 17
- **Rainier Ave:** Utilities and pavement need more design. Presenting update and seeking Council feedback September 18
- **Speed Radar Signs (6):** Installed on gateway roads: Bodega Ave., I St., D St., and Lakeville Hwy.

Bicycle Repair Stations

- Leadership Petaluma Class 2023's project purchased five bicycle fix-it stations for installation in Petaluma
- Current proposed locations include the Water Street Bike/Ped Bridge, Lynch Creek Trail at Lucchesi Park, Prince Park, Mary Isaak Center, and the Downtown SMART Station
