Dear Mayor and Council Members,

As you are aware, there were multiple hate speech attacks across both Marin and Sonoma counties in the past few weeks. In Petaluma, haters posted white supremacist / antisemitic hate in downtown. In Sonoma County, the board of supervisors and Santa Rosa school board meetings were among several that were zoom bombed with hate speech attacks.

We need to be prepared as a city ASAP to respond effectively to these incidents. Describing white supremacist hate speech attacks as merely "vandalism" lacks vital context to what happened, and does not offer our community the knowledge they need to make safety decisions for themselves.

STEP 1: Council should quickly adopt unanimously a resolution against antisemitism and ALL forms of hate speech. Sonoma County unanimously passed a gold resolution this year:

STEP 2: The resolution should be a catalyst for improvements - for example:

>> **ACTION:** Accelerate implementing the recommendations of the AHCAC: https://cityofpetaluma.org/documents/ahcac-final-report/. Many recommendations are not completed from these 2021 recommendations.

>> ACTION: "law enforcement and local jurisdictions to report all hate crimes"

- In this instance, since the vandalism was hate speech, the city should have reported this. The city needs to strengthen its communication strategy regarding hate attacks.

>> ACTION: "local governments to strengthen social services to support survivors of hate crimes and their communities. These may include victim compensation programs, victim advocate programs, culturally competent mental health services, and solidarity building initiatives such as restorative justice programs."

- The Petaluma Ad Hoc Community Advisory Committee (AHCAC) recommended years ago the creation of a multicultural center including restorative justice programming along with a committee of residents to oversee the program.
